Addendum to the Principal Brochure for AXA Central Provident Fund

IMPORTANT INFORMATION

1. The AXA Central Provident Fund (the “**AXA CPF**”) is a master trust designed to comply with the Occupational Retirement Schemes Ordinance (“**ORSO**”).
2. The guarantee of the Guaranteed Fund Policy is given by AXA China Region Insurance Company (Bermuda) Limited (the “**Insurer**”). Your investments in this insurance policy, if any, are therefore subject to the credit risks of the Insurer. The Insurer will only provide a guarantee of capital and a prescribed guarantee rate of return in certain specified circumstances. Please refer to the Appendix of this Principal Brochure for details of the guarantee features and guarantee conditions.
3. Each of the (a) Stable Fund Policy, (b) Balanced Fund Policy, (c) Growth Fund Policy; (d) AXA Stable Fund Policy; (e) AXA Balanced Fund Policy; (f) AXA Growth Fund Policy; and (g) AXA – RCM Hong Kong Fund Policy under the AXA CPF is an insurance policy issued by AXA China Region Insurance Company (Bermuda) Limited. Your investments in any of these policies, if any, are therefore subject to the credit risk of AXA China Region Insurance Company (Bermuda) Limited.
4. You should consider your own risk tolerance level and financial circumstances before making any investment choices. When, in your selection of investment choices, you are in doubt as to whether a particular investment choice is suitable for you (including whether it is consistent with your investment objectives), you should seek financial and/or professional advice and choose the investment option(s) most suitable for you taking into account your circumstances.
5. You should read the Principal Brochure for further details including product features, fees and charges and risk factors.

This Addendum shall be effective on 15 July 2011 and should be read in conjunction with and forms part of the Principal Brochure for AXA CPF (June 2011 edition).

By this Addendum, the Principal Brochure of AXA Central Provident Fund shall be amended as follows:

1. All references to the Chinese name of **AXA Central Provident Fund** 「國衛中央公積金」, shall be renamed to 「**AXA 中央公積金**」; while the English name will remain unchanged.

3. All references to the Chinese name of **AXA China Region Trustees Limited** 「國衛信託有限公司」, shall be renamed to 「**安盛信託有限公司**」; while the English name will remain unchanged.

4. All references to the Chinese name of **AXA China Region Insurance Company (Bermuda) Limited** 「國衛保險（百慕達）有限公司」，shall be renamed to 「安盛保險（百慕達）有限公司」；while the English name will remain unchanged.
5. All references to the Chinese name of **AXA China Region Investment Services Limited** 「國衛投資服務有限公司」，shall be renamed to 「安盛投資服務有限公司」；while the English name will remain unchanged.
6. All references to the Chinese name of **AXA Unit Trusts – Global Fund** 「國衛環球基金」，shall be renamed to 「AXA 環球基金」；while the English name will remain unchanged.
7. All references to the Chinese name of **AXA Unit Trusts – Pacific Fund** 「國衛太平洋基金」，shall be renamed to 「AXA 太平洋基金」；while the English name will remain unchanged.
8. All references to the Chinese name of **AXA Unit Trusts – Currency and Bond Fund** 「國衛外匯及債券基金」，shall be renamed to 「AXA 外匯及債券基金」；while the English name will remain unchanged.
9. All references to the Chinese name of **AXA Unit Trusts** 「國衛基金」，shall be renamed to 「AXA 基金」；while the English name will remain unchanged.
10. All references to the Chinese address of **G/F AXA Centre, 151 Gloucester Road, Hong Kong** 「香港告士打道 151 號國衛中心地下」，shall be changed to 「香港告士打道 151 號安盛中心地下」；while the English address will remain unchanged.
11. All references to the Chinese address of **20/F AXA Centre, 151 Gloucester Road, Hong Kong** 「香港告士打道 151 號國衛中心二十樓」，shall be changed to 「香港告士打道 151 號安盛中心二十樓」；while the English address will remain unchanged.
12. With effect from 26th April 2011, the registered address of RCM Asia Pacific Limited (the Manager of AXA – RCM Hong Kong Fund Policy) has been changed as follow:
